SENATOBIA - The possibility N that the charred body found near he y Coldwater Thursday afternoon d would be identified Saturday faded re when a missing Clarksdale wom- for an was found in a Memphis hosd pital.

Tate County Sheriff W. T. Freeman said that the body matched the description of Lola Newman, who disappeared from her home near Clarksdale August 4th.

The father was to examine the charred remains of a young woman found in the ruins of a vacant house on the farm of Sterling Wynne, between Coldwater and Independence. However, the girl was located early Saturday in Memphis.

Another family arrived at Senatobia Saturday afternoon to determine if the body may be their missing daughter, but the sheriff said they had just arrived and that they had not seen the charred body. He did not identify the familv.

An autopsy in Jackson showed the young woman to be about 20, five feet five inches tall and weighing about 120 pounds. The report e revealed the woman was murdered before the first, leading officers to believe that her body was placed in the building and set ablaze.

The dead woman was described as white, 20 years old, five feet, five inches tall, weighing from 100 to 120 pounds wearing a shirt or blouse and skirt or slacks both of coarse material, and haveing a partial gold crown on a front tooth.
